Parental Control Policy

Note: - In order to comply with our insurers via BMFA we have to show that we have a policy in place to protect children as defined in the “Children’s Act” and Vulnerable adults.

The policy is as follows and is named the “Parental control policy”

Parental control policy :- Membership is open to all persons under the age of 18 years but in order to comply with the above policy, must at all times be supervised by a parent/guardian in all club organised activities.

This might seem harsh since you can get married at 16, join the armed services at 16 and drive at 17, but as the flying site is remote from public transport, young members would need to be brought to the site anyway.

If the parent/guardian cannot stay on site, then a signed letter of authority can be presented and supervision can be undertaken by any of our members but only by prior arrangement to be sure that they will be in attendance.

Data Protection

In order to comply with the latest Data Protection Act the club is required to ask applicants if they agree to have their details stored on the clubs database. By answering “yes” to the question and signing your application you have agreed to your data being stored on the club's database.

The club (H&DRCMC) undertakes to keep any stored data secure and not to share it with any other entity other than any lawful authority that may request it.
